

**PROCEEDINGS OF THE 2ND MEETING OF KEONJHAR DISTRICT MINERAL
(TRUST BOARD) HELD ON 31.05.2016 AT 11.30 AM IN DURBAR HALL,
KEONJHAR**

The 2ND meeting of the District Mineral Foundation (Trust Board) was held on 31.05.2016, at 11.30 am in Durbar hall of Collectorate, Keonjhar under the chairmanship of Collector Keonjhar cum Managing Trustee, DMF Board Keonjhar. The list of member present in the meeting is annexed at A.

At the outset the Managing Trustee welcomed all members of the Trust and highlighted the importance of District Mineral Foundation in the process of development of the district. He brought to the notice of the trust that an amount of Rs.280.00 crore (approx) has been collected and more amount to be collected towards the royalty of the mines which is approximately Rs.150.00 crore for which mine owners have been directed to deposit the amount as soon as possible. Deputy Director, Mines, Joda has to take necessary steps for instructing the defaulting mine owners.

Collector cum Chairperson suggested the Board for utilization of fund in the ratio of 70:30 for Mining affected and Non mining areas respectively in the District which was accepted by all after due discussion.

According to notification and the decision of the Board the funds for the 1st year i.e. 2016-17 shall be utilized for the high priority activities like Drinking water supply and sanitation, Health Sector, Education, Women and Child Development and Skill Development and other priority activities i.e. major roads relating to Rural Works Department and R&B Division. The project proposals approved in the board meeting is annexed at B.

Suggestions of Collector for earmarking an amount of Rs.55.00 Crore for Civil Construction of Medical College, Keonjhar was accepted by all the members of the Trust, and duly included in the list of projects.

Collector suggested for constitution of a Technical Screening Committee for chalk out the feasibility of the project proposals under DMF.

During the discussion the line departments like R&B & RWD suggested for exemption of Pro-rata Charges in the estimation. Collector viewing this matter suggested to request in Finance Department, Odisha for consideration.

In the meeting the following project proposals were discussed for approval of fund under DMF for the year 2016-17 as per availability of funds.

1. Rangadihi – Fuljhar to Jagadala 10km road (R&B Keonjhar)
2. Barbil Town to Nalda gate via Mahanta Sahi road (R&B Keonjhar)
3. Baebari to Guruda via Palasa 8 km road (R&B Keonjhar)
4. Deogaon-Narangapur-Barigaon Road (R&B, Ghatgaon)
5. Jhadaga to Bhuyan Roida road (RWD-II, Keonjhar)
6. Belai Pada to Kuldham road (RWD-II, Keonjhar)
7. Jamdapap to kankadapat (RWD-II, Keonjhar)
8. Dubuna to Pidhapokhori road (RWD-II, Keonjhar)
9. Jamdapap to kankadapat road (RWD-II, Keonjhar)
10. Kendudihi to Dhanurjaypur road (RWD-II, Keonjhar)
11. Improvement of Street Lights in Keonjhar Municipality.

Water supply and sanitation would be given importance not only in the mining affected villages but also in non mining areas in course of time.

At last the meeting ended with vote of thanks to the chair and all other members present in the meeting by Sri Sangram Keshari Swain ADM, Keonjhar.




