**PROCEEDING OF THE 10th DISTRICT MINERAL FOUNDATION, KEONJHAR TRUST BOARD
MEETING HELD ON 24.06.2021 AT 11AM VIRTUALLY THROUGH GOOGLE MEET**

The 10th Trust Board meeting of DMF was called as per the clause 8 of the DMF Trust Deed. The meeting was held on 24.06.2021 at 11 AM virtually on Google Meet under the chairmanship of Shri Ashish Thakare, IAS, Collector-Cum-Chairman & Managing Trustee, DMF. The list of participants is enclosed in the Annexure- I.

CEO DMF then shared the agenda for the 10th Trust Board Meeting which is as follows:

10. Vote of thanks by CEO DMF Keonjhar

Starting off as per the agenda, Collector welcomed all the Trust Board Members and the invitee participants present in the meeting. He also apprised the members that due to prevailing conditions of COVID19, physical meeting couldn't be held for the past few months. However, since the situation is not looking favourable to improve, therefore an online meeting is called to take up matters of importance. Following this, PD DRDA-Cum-Chief Executive Officer, DMF informed the meeting that minutes of the meeting for the 9th Trust Board Meeting held on 02.05.2020 has been sent to all members via e-mail. It was then confirmed & approved by the members.

Collector then gave a brief presentation on DMF fund accrual and expenditure status sector wise/department wise updated as on 31st May 2021, which is as follows:

Total Receipt of funds- 5890.12 Cr
Sanction of Funds- 3912.58 Cr
Amount of Released funds- 2418.86 Cr
Projects Sanctioned- 1140

Projects Completed – 638
Ongoing Projects- 331
Projects Not started- 157
Projects Cancelled- 14

Following this, Collector also highlighted various sector wise initiatives taken up under DMF since 9th Trust Board Meeting, where a lot of projects/works have been initiated and executed in the mining areas. He then requested respective line departments to present the major projects sanctioned under DMF.

EE R&B Keonjhar presented the details of major road and building projects. Hon. MLA Sadar expressed his concern regarding the delay in the progress of Medical College and Rangadihi-

Phuljhar-Balabhadrapur-Jagadala Dam Road. He requested the department to complete it on priority basis as it has been a major demand from the public in the district. EE R&B responding to this informed that the said road has been taken up in three phases, where last phase was recently sanctioned and has been already tendered. He assured the meeting that it will be completed by Dec 2021. Whereas regarding medical college, he informed that efforts are being taken to ensure its completion at the earliest.

Subsequently, EE RD I/II/Anandapur presented the details of major projects sanctioned. EE RD II Keonjhar mentioned that for Dubuna-Pidapokhari road project, a length of 3.5 km passes through the mining lease of OMC. A letter requesting for clearance has already been submitted to the Executive Director (F&E) OMC Ltd, Bhubaneswar vide letter no 4341 dated, 13.11.20. But no reply has not been received till date. Collector then informed the meeting that RM, OMC Keonjhar has been informed about this and subsequently he will take it up with MD, OMC for its early resolution. For a road project 'Construction from Tukuna to Ambo' under EE RD Anandapur, Hon. MLA, Anandpur expressed his concern regarding quality of road being constructed. Responding to this, EE Anandpur assured to take up remedial measures and see that there is no compromise in quality of work across all the projects. Further EE, Anandpur highlighted the issue in 'Malliposi to Sarat road' where a section of road falling in Mayurbhanj district is required for seamless connectivity. Collector Keonjhar informed that he will discuss the matter with Collector, Mayurbhanj.

Following this, GM OBCC Bhubaneswar presented the details of the ongoing projects namely 'Construction of Joda Flyover' and 'Barbil Ring Road'. He highlighted the land acquisition and eviction issues in the 'Joda Flyover' project and informed that eviction notice has been served to all the encroachers by Municipal Authority. He then informed that as per the latest circular, eviction cannot be conducted during the lock down period and will be initiated once unlock begins. He emphasized that without eviction, the construction activities cannot be started in full swing. Taking note of this fact, Hon. MLA Sadar mentioned that work needs to be expedited as this project is a lifeline for the Joda-Barbil mining affected area. Collector and Hon. MLA Champua also agreed to undertake a joint visit for carrying out assessment of Barbil ring road and finding resolution for certain challenges as highlighted by OBCC.

Following this, Collector briefed the meeting on COVID management and ongoing vaccination drive in the district. He highlighted that during the second wave, COVID Hospital Ranki saw an increase in ICU beds from 14 to 44 and ventilators from 08 to 26. Also, with the hospital partner it was ensured that enough trained doctors and nurses are on board for providing the COVID treatment for the affected patients. Apart from this, oxygen generator was installed during the onset of second wave additional High Dependency Units (HDUs) have been setup. He also assured the DMF Trust Board that district administration has a strict management for ensuring the treatment and service delivery at COVID Hospital and Covid Care Centres (CCCs) where all the basic essentials like Oxygen Supply, Food, Hygiene Issues, Feedback to patient attendants are being monitored and reviewed on hourly basis.

Further Collector briefed the meeting that preparations for scaling up the facilities for possible COVID third wave are ongoing. District health personnel's including doctors and paramedics have undertaken a first round of training on COVID Treatment Protocol, Oxygen Administration, Operating Ventilator and hands on training on other lifesaving technologies

and equipment's made available at COVID Hospital. Apart from this, expansion of ICUs has been planned at SDH Anandpur/Champua & Centenary building at DHH Keonjhar. Also, efforts are underway to upgrade/scale up Pediatric facilities at DHH considering the alert from health experts anticipating COVID affecting children. It is also being planned to setup oxygen plants at Sub Divisional Level. Collector also informed the meeting that Keonjhar has now two operational RT PCR labs with a capacity to test 1000 samples per day which will help in expediting the COVID test results and reduce the dependency on state. All the funding for COVID management at COVID Hospital and CCCs has been taken up under DMF. All the Trust Board members appreciated the efforts taken up. Hon. MLA Sadar while appreciating the efforts thanked the district administration for the steps taken to contain the spread of COVID.

CDMO then presented the activities taken up from DMF under health sector. Hon. MLA Sadar praised the initiative taken up for establishing cancer treatment facility in the district along with dialysis centre at Barbil. However, he expressed his concern regarding the unavailability of qualified doctors from the COVID Hospital partner hospital at Ranki. CDMO assured him that district is also assisting with HR support wherever required in case there is a felt shortfall of doctors or as per increase in COVID case load. Further, Hon. MLA Anandpur opined to strengthen the COVID preparedness in village areas of the district and urged to hold vaccination camps for 18-44 Years in ward no 1-7 in Anandpur and urged to assess the feasibility and usage for ECMO machine. CDMO assured that vaccination has already been initiated in the said wards.

Further, EE PHED Keonjhar presented the progress of ongoing projects for 'Urban Water Supply'. There is only one project which is ongoing while rest has been completed. Collector taking note of this, requested him to share a timeline on providing individual household connection in all the wards of all urban local bodies. EE PHD assured to provide the details as soon as possible.

Following this, EE, RWSS Keonjhar presented the status of the Mega PWS and informed that the work has been delayed a bit due to COVID pandemic but will be completed by Feb'2022. He informed that delay is majorly due to villagers not allowing the workers to undertake works out of their fear of COVID and few locations required forest/land clearance, which is being pursued for its early disposal. EE, RWSS Anandpur while presenting the ongoing work informed the meeting that the work progress is delayed due to COVID and land clearance but ensured it will be completed by 2022. Hon. MLA Anandpur raised a concern regarding the damage being done to the roads due to ongoing pipeline laying work. The concerned agency is not repairing the damaged roads and pits are left open after excavation. He enquired regarding the onus and responsibility for undertaking the repair work, to which both the divisions responded by assuring that this matter will be enquired on case to case basis with the agencies and necessary agreement clauses will be initiated to carry out repair at earliest. Hon. MLA Sadar requested both the divisions to expediate the work and complete the work as per schedule.

Further, DFO Keonjhar gave a brief presentation of all the projects. For development of Panchabati Medicinal Park within the triangle (Bada Ghagara, Sana Ghagara and Anjar) with the help of local community, he proposed a multi-facility centre with eco-tourism to attract tourists. Hon. MLA Sadar proposed to include Siddhamatha as part of the above-mentioned

cluster and additionally proposed to assess feasibility of a ropeway from Siddhamatha to Sanaghagara. DFO Keonjhar responded in affirmative and assured to assess and come back with details.

Further, DFO Anandpur presented the progress and status of DMF sanctioned projects. Raising a query, Sarpanch, Rasol GP requested him to provide reasons for slow progress of the work, 'Improvement of Pancham chhaka to Nardangipentha Forest Road' to which DFO responded that due to damage to nallah by subsequent flow of water, the budget requires a revision where culvert on nallah would be done along with guard/ retaining walls. However, he assured that all efforts are being undertaken to get the work completed at the earliest.

Subsequently, DEO Keonjhar briefly provided the details on various interventions taken up under DMF. DEO while highlighting the significance of School Transformation initiative of schools under ST in 100 schools, spelt out various activities being undertaken ranging from providing grants for sports/libraries, setting up smart classes, campus upgradation, additional classrooms, school repair and many more. Hon. MLA Sadar while appreciating the activities shared that when he last visited an upper primary school of Tala Kainsari in Banspal, he found that classrooms were not enough as per the enrolment. He further enquired if there has been any assessment report available regarding the requirement of infrastructure across all the schools. He then requested that if there is any, then same shall be made available. DEO responded in affirmative and assured to provide him with the details at the earliest.

Concluding the presentation, several line departments namely DD Horticulture, AD Sericulture and CDAO presented on the livelihood initiatives undertaken under DMF. Hon. MLA Sadar requested the departments to develop a data base of the impact and outreach of the livelihood programmes which will comprise the interventions undertaken, increase in income, cropping pattern, benefits accrued by the families from the interventions etc. Collector assured that this will be undertaken by the departments.

Further, Hon. MLA Sadar enquired the chair whether doctors/nurses and paramedics are deployed across health institution as per IPHS norms. He also added and requested to inform whether there has been any assessment undertaken for this. Additionally, he advised to carry out an assessment/evaluation in this regard. Responding to this, Collector informed the meeting that a project in this regard has already put up for approval of trust board and soon this will be undertaken. However, shortage of doctors and their deployment as per IPHS norms is still a challenge as its difficult to fill vacancies for remote locations. Even then DMF is carrying out special recruitment of doctors to fill the vacancies and post doctors as per IPHS norms across all the health facilities especially in the mining affected areas. With funding support from DMF, several facilities across the district this year has received recognition from state namely Kayakalp Award and ISO certification for PHCs and CHCs.

Moving on to the next agenda, list of a total of 250 projects was placed before the trust board. Hon. MLA Sadar mentioned his inability to comprehend the details of the said projects and added that more time shall be given for its detailed study. Collector mentioned that as per his request in 9th Trust Board Meeting, this time the projects and all the documents placed in Trust Board Meeting were shared well ahead in advance for each member's kind perusal and study. Hon. MLA Sadar then sought clarity on the proposed projects namely 'COVID

Assistance' and 'Support to Child Care Institutions (CCIs)'. Collector while responding to this explained that details for COVID assistance has not been worked out and it may be planned in line with state schemes for assistance to COVID affected families. Whereas for the CCIs, there was an immediate need for assistance as the children were suffering due to the hardships faced by the institutions and aggravated during COVID pandemic. While for other projects, Collector mentioned that the detailed project report/concept plan require further consultative and planning process with state government, line departments and field study. Therefore, it is difficult to publish/prepare DPR in advance, meanwhile considering the project priority and importance/emergency/seasonality, the proposals are sought from the trust board members, Panchayati Raj Institution Members and line departments and are then placed for board's approval. After deliberations with the other trust board members and incorporating their inputs, the annexed list of 250 projects with approximated estimated cost was approved in the DMF Trust Board.

Now, as per rule 15 & 16 of ODMF Rules, Annual Report with Audit of DMF accounts for the FY 2018-19 and FY 2019-20 was placed in the trust board. After deliberations, it was approved by the trust board. Also, CEO DMF informed that the 'Quotation Call Notice' for selection of auditor is proposed to be done for the FY 2020-21.

CEO DMF then moving to the next agenda, placed the DMF Action Plan and DMF Perspective cum Goals document for the FY 2021-22. Hon. MLA Sadar requested for clarification on the process/consultation undertaken for preparation of both the said plans. He also requested if there has been any third part assessment or outcome study done for the projects undertaken under DMF. Collector responded by saying that as mandated all the projects are being undertaken through line departments which are being monitored and assessed as per the guidelines/rules prescribed by central/state government. Moreover, for livelihood projects, there is a designed scope for social audit/third part assessment whichever is applicable. Adding to this, he mentioned that if required then said reports may be shared with Trust Board Members. The Annual Action Plan and Perspective Plan were then approved by the Trust Board.

Further, Hon. MLA Sadar inquired about the non-receipt of response for his letter submitted on 04.05.2021. He also requested the meeting to be convened more frequently or at least twice per year as mandated by DMF Trust Deed. Collector then mentioned that a response in this regard has already been dispatched. However, Collector mentioned that the response will be re-shared for his kind perusal. Also, he added that the due to the ongoing COVID pandemic and engagement of other hon'ble trust board members the meeting couldn't be convened but all efforts will be undertaken to conduct the meeting as mandated or whenever required/requested by the members.

At the end, the PD DRDA cum CEO DMF, Keonjhar thanked all the participants for their valuable suggestions and the meeting ended with a vote of thanks to the chair.

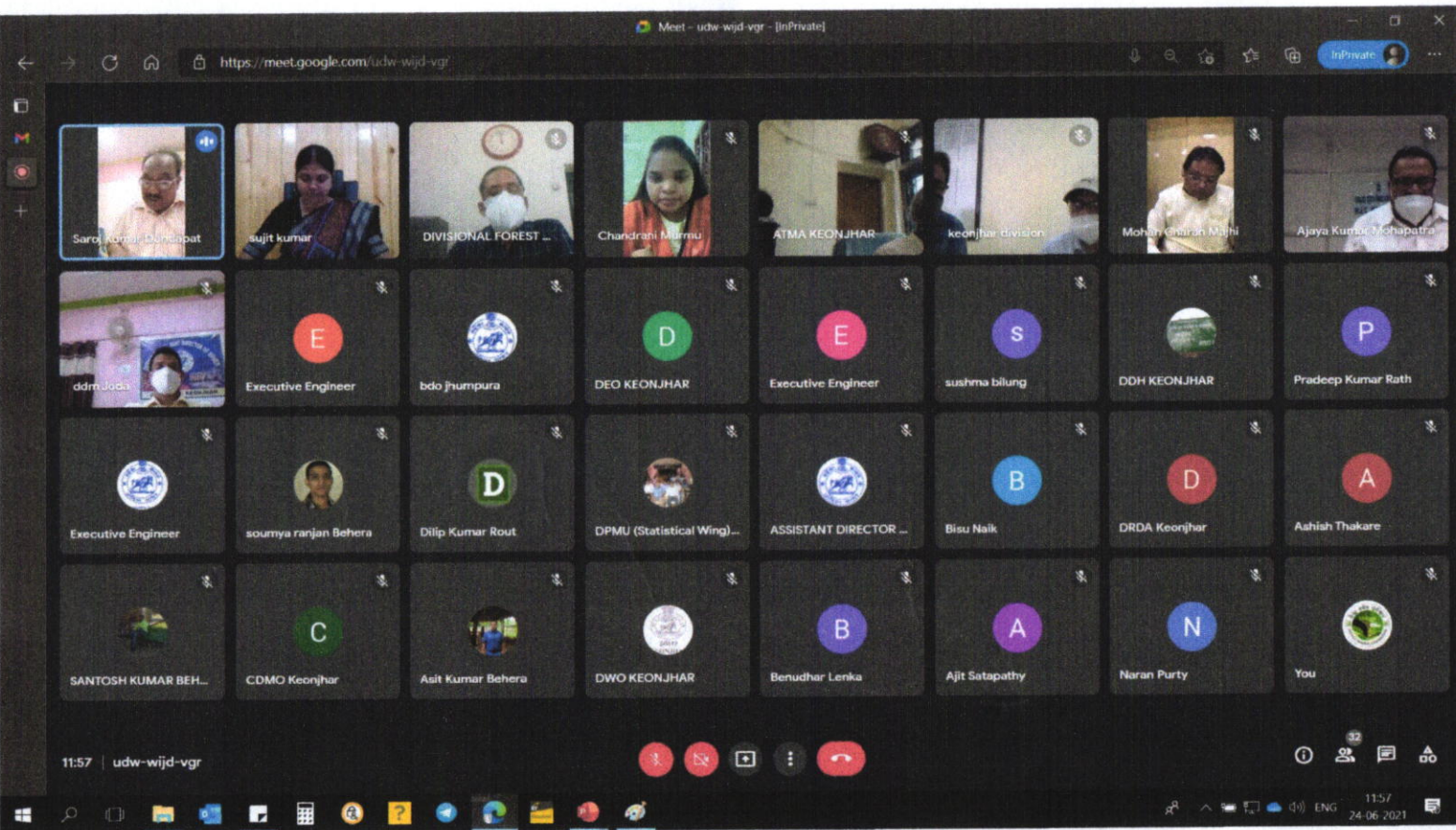
